1. BACKGROUND-

- 1.1. The Board of School Education Haryana, Bhiwani (BSEH) (hereinafter also referred to as the “Board”) came into existence in 1969 as per Haryana Act No. 11 of 1969 with its head-quarters at Chandigarh later shifted to Bhiwani in January 1981. The mission of BSEH is to prescribe relevant syllabi and text books, Fairly and Timely conducting of examinations, evaluation and declaration of results, Using information and communication technology in Board working to provide better services to stakeholder etc.
- 1.2. The detailed Physical Specifications and Quantity of the Markin Cloth are as under:

1.3. INSTRUCTION TO BIDDERS-

- 1.4. Any condition or qualification or any other stipulation contained in the Bid shall render the Bid liable to rejection as a non-responsive Bid. The bids shall be unconditional, firm and irrevocable.
- 1.5. The tender documents can be downloaded from Board’s website <https://bseh.org.in> & Govt. of Haryana e-tenders website <https://etenders.hry.nic.in>
- 1.6. The Bidders shall be responsible for all costs associated with the preparation of their Bids and their participation in the Bid. The Board will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

2. TECHNICAL QUALIFYING CRITERIA :- The bidder must possess minimum eligibility criteria mentioned here under to participate in the tender:-

- Tender Fee Rs. 1000/-(One thousand Only) and EMD Rs. 50000/-
- The bidder must have GST Registration and PAN number
- The bidder must submit an undertaking on its letter head regarding Debarred/Non-Blacklisting of Firm.
- The bidder must attach an undertaking having experience in this field.
- Bidder must attach Income Tax Returns of previous two years.
- Verified buyers must be required average annual turnover of rupees 01 crore (One crore) per year along with audited balance sheet verified by C.A. for financial year 2022-23, 2023-24.

3. **VALIDITY OF RATES** :- The rates quoted in the tender must remain valid for 180 days from the date of opening of **Technical Bid**. Rates will not be changed under any circumstances. The rate should be quoted in Indian rupees and also should be indicated both in words and figures. If the rates quoted in figure and words are different, the amount in words only will be considered. The unit's price should be for the same unit indicated in the tender notice. Prices should be at free delivery (F.O.R) to the Stationary Store in Board of School Education Haryana, Bhiwani. The rate should be inclusive of all charges and tax etc. wherever applicable and the chargeable amounts should be clearly mentioned in one sheet. In absence of any specific mention the rate shall be assumed to be inclusive of all taxes.
4. **VALIDITY OF CONTRACT**: Validity of Contract will be for One Year which can be extended for further two years on the basis of satisfactory performance of the firm/Agency.
5. **INSPECTION & DELIVERY PERIOD**:- Supply of the material within 25 days to the Board's office.
In case of defective supply due to latent manufacturing defects/transit damage, the same has to be removed and replaced by the supplier at its own cost.

6. **CLARIFICATIONS**

- 6.1. BSEH shall endeavor to respond to the questions raised or clarifications sought by the Bidders. However, BSEH reserves the right to not respond to any question or provide any clarification, in its sole discretion.
- 6.2. BSEH may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Bidders. All clarifications and interpretations issued by BSEH shall be deemed to be part of the Tender Document.

7. **AMENDMENT OF TENDER DOCUMENT**

- 7.1. At any time prior to the Bid Due Date, Secretary, Board of School Education, Haryana may for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the Tender Document by the issuance of Addendum.
- 7.2. In order to afford the Bidders a reasonable time for taking an Addendum into account, or for any other reason, Board may, at its own discretion, extend the Bid Due Date.

8. **RIGHT TO ACCEPT AND TO REJECT ANY OR ALL BIDS**

- 8.1. Notwithstanding anything contained in this Tender Document, Secretary, Board of School Education Haryana, Bhiwani reserves the right to accept or reject any or all Bids at any time during the Bidding Process without any liability or any obligation for such acceptance, rejection or annulment and without assigning any reasons thereof.

9. **TENDER FEE & BID SECURITY (EMD)**:-

- 9.1. The cost of this bid document is Rs.1000/- (One Thousand only) [non-refundable] and an amount of Rs. 50000/-(Fifty Thousand only) should be deposited as EMD for participating in tender process. Slips of deposited Tender Fee and EMD should be enclosed /uploaded with e-tender documents failing which tender will not be considered. The MSME firms/agencies only registered in Haryana will be entitled for exemption as per the instructions issued by the Govt. of Haryana from time-to-time, the proof of the firm having MSME must be enclose/upload with the tender documents.
- 9.2. EMD has to be deposited through Online mode.

- 9.3. The EMD of unsuccessful Bidders will be returned through the online payment portal.
- 9.4. EMD and Performance Security of successful bidder will be returned after satisfactory completion of work and final payment of the bill.
- 9.5. The EMD shall be forfeited as damages without prejudice to any other right or remedy that may be available to the Board under the Bidding Documents or otherwise, under the following conditions:
- a) If a Bidder submits a non-responsive Bid;
 - b) If the Bidder withdraws its Bid during the Bid Validity Period as specified in this TENDER DOCUMENT and as extended by mutual consent of the respective Bidder(s) and the Board;
 - c) If the Bidder submits a conditional Bid which would affect unfairly the competitive position of other Bidders who submitted substantially responsive Bids.
 - d) If a Bidder engages in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice;
 - e) Any other conditions, for which forfeiture of Bid Security has been provided under this Tender Document.

10. RIGHT TO VARY SCOPE OF WORK AT THE TIME OF AWARD-

- 10.1. Secretary, Board of School Education Haryana, Bhiwani reserves the right to vary the quantity.
- 10.2. If any such change causes an increase or decrease in the cost of or the time required for the Bidder's performance of any part of the work, whether changed or not changed by the order, an equitable adjustment shall be made in the value or time schedule, or both. Any claims by the Bidder for adjustment under this Clause must be asserted within fifteen (15) days from date of the Bidder's receipt of BSEH's order for change.
- 10.3. Secretary, Board of School Education Haryana, Bhiwani may at any time, by a written order given to the Bidder, make changes to the Scope of the work.

11. TERMS & CONDITIONS-

- 11.1. Secretary, Board of School Education Haryana, Bhiwani reserves the right to reject the Application/ Bid of any Bidder who is a defaulter to the Board.
- 11.2. Response submitted by Fax, E-mail, Offline or any form other than mentioned above will not be accepted and liable to be rejection.
- 11.3. It will be understood that the Bidders have quoted their rates after inspection of the site(s).
- 11.4. In case the successful bidder resiles from the offer within the validity of tender, the earnest money will be forfeited. Similarly if successful contractor fails to commence the work within stipulated time, the amount of earnest money will also be forfeited besides blacklisting the firm.
- 11.5. For any situation/reason beyond control of the bidder, the extension of time may be granted on an application/request of the bidder before completion of work. No claim for any compensation during the extended period shall be entertained and the Secretary decision in this regard shall be final.

12. **PERFORMANCE SECURITY:-** The successful bidders shall furnish Performance Security an amount equal to 10% of the contract value through RTGS in favour of "Secretary, Board of School Education Haryana, Bhiwani". Performance Security and Agreement to be furnished within 07(Seven) days from the date of issuance of intimation letter regarding acceptance of Bid, failing which a penalty of

- 12.1. Offline tender will not be accepted.
- 12.2. The Bids will be opened in the presence of Bidders or their authorized representatives, who may wish to be present. So it is advised that authorized representatives should bring authority letters from their firm.

13. ARBITRATION CLAUSE:-

All disputes or differences arising between the parties out of or relating to meaning and operation of effect of the contract or breach thereof shall be settled by arbitration in accordance with the rules and regulations of arbitrator. In case of any legal dispute the jurisdiction will be at Bhiwani. The sole arbitrator shall be appointed on mutual concurrence of both parties and the decision of the arbitrator shall be binding on both the parties.

14. BLACKLISTING THE FIRM :- If a firm which is awarded the contract violates any of the term & condition, it shall be black listed & its EMD/Performance Security shall be forfeited.

- 14.1. The Secretary, Board of School Education Haryana, Bhiwani reserves the right to reject any bid which does not fulfill the conditions stipulated in the tender i.e., the bids not qualifying the specifications specified in the tender and other conditions stipulated in the tender will be rejected.
- 14.2. The Secretary, Board of School Education Haryana reserves the right to cancel the tender without assigning any reason thereof.
- 14.3. All Bidders/Vendors must quote the rates inclusive all of taxes. Transport and labour charges etc. shall be borne by the Firm/Agency.
- 14.4. The office will not provide any road permit to the successful bidder for the supply of the material at FOR destination.
- 14.5. In case of any dispute, the courts at Bhiwani only will be the legal jurisdiction.

15. WARRANTY-

- 15.1. Must provide for free-of-cost complete replacement of the concerned module of the item, for any fault, malfunctioning or defect found at any stage.

16. PAYMENTS-

- 16.1 Earnest money and performance security will be returned after final payment to the firm. **75% payment** will be made after the delivery and checking the material by the Committee at Bhiwani and **balance 25% payment** will be released after Lab test.
- 16.2. Lab Testing: - After supplying of Markin Cloth a Lab testing report will be obtained from Dept. of Industries and Commerce Haryana, Govt. Quality Marking Center for Textile Goods. The Lab testing charge will be paid by the firm. Final payment will be released according to the Lab testing report.
- 16.3. Additionally, all payments to be made to the Agency shall be inclusive of all statutory levies duties, taxes and other charges whenever levied/applicable. Any increase in rates of all applicable direct or indirect taxes (central or state or local), rates, duties, charges and levies (central or state or local); will be to the account of Agency. The Agency shall also bear all personal/income taxes levied or imposed on its personnel on account of payment received under this work. Agency shall further bear all income/corporate taxes, levied or imposed on account of payments received by it from the BSEH for the work done.

- 16.4 In case of supply of defected cloth value of that items will be imposed as penalty along with original cost of that defective goods on the bidder or replace the defected materials at his on cost with in a week In case of defect in composition as per lab test report, the double penalty in proportionate of composition defect will be imposed. However 2% +,- will be ignored.

17. PENALTY CLAUSE-

17.1. In case of late delivery:

If the items are not supplied within the stipulated time period, the penalty will be imposed as under:-

- i) For delay up to 05 days – 2% penalty on the payable amount.
- ii) For delay 06 to 10 days – 5% penalty on the payable amount.

- 17.2. In case of non-supply of Item by the firm/supplier after getting the supply order, EMD and/or Performance Security deposited by the firm will be forfeited and firm will be Blacklisted for a specific period.

18. FRAUD AND CORRUPT PRACTICES-

- 18.1 The Bidders and their respective officers, employees, agents and advisers shall observe the highest standard of ethics during the Bidding Process and subsequent to the issue of the LOI (Letter of Intent) and during the subsistence of the commissioning etc.
- 18.2 If a Bidder is found by the Board to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, or after the issue of the LOI, such Bidder shall not be eligible to participate in any tender or TENDER DOCUMENT issued by the Board for a specific period.
