## **A. Scope of Work: -**

To provide link bandwidth for existing Wi-Fi setup. 500 Mbps dedicated symmetric internet bandwidth (1:1 uncompressed and unshared with last mile on fiber in ring topology) connectivity through leased line with assured bandwidth of 500 Mbps with 1:1 duplex. This includes setting up of last mile connectivity preferably using OFC Technology, installation of necessary equipment, deploying of cable up to Ethernet port with BSEH existing Local Area Network. The termination of the last mile connection is to be made in Server Room of the BSEH and on-site maintenance of existing wireless networking equipment and server room. The distribution of lease line and to maintain the management software, one man power (Technically sound/ Professional) will be deputed by the firm for this purpose in Board's office in office hours.

Contract Period: - Initially for One Year which can be extended further for three years on yearly basis on satisfactory services of the firm.

## **B. Technical Qualification Criteria: -**

1. Tender Fee (Rs.1000/-) & EMD (Rs.20,000/-) to be deposited through E-tender portal. Both deposited slips should be enclosed and uploaded with e-tender documents failing which tender shall be rejected.
2. The Bidder should attach A/ B Level license.
3. Copy of GST & PAN Certificate must also be attached.
4. The minimum turnover should be 20 Lacs during the last two financial years i.e 2022-2023 and 2023-2024 duly verified by CA.
5. Bidder must produce non-Blacklisting Certificate of the firm on non-judicial stamp paper of Rs. 100/- duly attested by the Notary (As per Annexure-1).
6. MSME Firms registered only in Haryana state are entitled/eligible for relaxation under this provision as per instructions of the appropriate Government/Authority.
7. The firm should have minimum three years' experience in the field of providing Internet services and at least one satisfactory completion certificate should be attached.

## General Terms & Conditions

1. Bids shall remain valid for 90 days from the date of opening of technical bids.
2. After receiving notification of award, firm have to deposit an Agreement as per contract form on Non-Judicial Stamp Paper of Rs.100/- duly attested by Notary along with 10% Performance Security/Bank Guarantee of the total value of the tender within seven (7) days failing which a penalty of rupees 1000/- per day will be imposed for five days. Thereafter EMD may be forfeited and firm may be blacklisted.
3. EMD & Performance Security will be returned after final payment of the bill & termination of contract.
4. The Chairman, Board of School Education Haryana, Bhiwani is the final competent authority to approve the tender and to settle all issues including waiving off penalty related to the tender and even to relax or amend any of the terms & conditions after issuance of the tender and his orders shall be final and binding for one and all, in all respects.
5. Firm have to set up the required instruments in the Board's office within seven (7) days from the date of placing the work order.
6. The approved vendor shall ensure timely supply as per scope of work and rates during the currency of the rate contract. An undertaking (on non-judicial stamp paper of Rs. 100/- & attested by notary) to this effect, invariably as under failing which their tender will not be considered for evaluation as per Annexure-I
7. Rates should be quoted strictly as per the tender specifications and contract should be valid for a period of one year, which can be extended for further three years on yearly basis on satisfactory services of the firm.
8. For further distribution of lease line and to maintain the management, one person (Technically sound/ Professional) will be provided in Board's office by the firm and his expenses/salary will be paid by the firm.
9. If the Bidder gives a false statement on any of the above information, the firm/supplier will not be considered and their quotation/tender shall be deemed to be rejected and the security deposited will stand forfeited.
10. Arbitrator clause: All disputes or differences arising between the parties out of or relating to meaning and operation of effect of the contract or breach thereof shall be settled by arbitration in accordance with the rules and regulation of arbitrator. The sole arbitrator shall be appointed on mutual concurrence of both parties. However, it is the discretion of the Chairman to accept or not decision of the Arbitrator. The courts at Bhiwani only will have the legal jurisdiction in case of any dispute.
11. During Breakdown of Lease Line alternate Connection on Radio Frequency (R.F) will be provided by the vendor.
12. The firm will provide and deploy the firewall hardware facilities for up to 1000 users for smooth working of internet.
13. The firm will have to provide free access of internet services to Board authorities regarding any site which Board authorities needs to be connected.
