The defendant has opportunity to obey the direction given by this hon'ble court but has willfully and intentionally failed to obey the same till now as such as per the provisions of order 21 rule 32 of the CPC, he is liable to be detailed in the civil imprisonment till he complies with the direction given by this Hon'ble court or the amount of rs. 367300/- may be recovered by way of attachment of the bank account other moveable or immoveable properties of the Board costs of the execution may also be recovered.
