# 1. Scope of Work

i. BSEH requires 04 Air Conditioner with stabilizer for office use.

ii. The detailed Technical Specifications and quantity required of the Air Conditioner are as under:-

#### 2. Instruction to Bidders-

- i. Any condition or qualification or any other stipulation contained in the Bid shall render the Bid liable to rejection as a non-responsive Bid. The bids shall be unconditional, firm and irrevocable.
- ii. The Bidders shall be responsible for all costs associated with the preparation of their Bids and their participation in the Bid. The Board will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.
- iii. Any entity which has been barred by the [Central/ State Government, or any entity controlled by it] from participating in any project, and the bar subsists as on the date of bidding, would not be eligible to submit a Bid.

### 3. Technical Qualifying Criteria

The tenderer must possess minimum eligibility criteria mentioned here under to participate in the tender-

- a) Bidder must deposit Tender fee of Rs. 1000/-(One Thousand only) (non-refundable) and EMD of Rs 10,000/- (Ten Thousand only) is to be deposited through tender portal.
- b) Bidder must be authorized dealer/retailor of the Company (Mitsubishi, Carrier, O General). Certificate must be attached.
- c) The bidder must have GST Registration, PAN number.
- d) Bidder must have annual turnover of Rs. 5,00,000/- of last two year i.e. 2022-23 and 2023-24. Balance sheet verified by CA must be attached.
- e) Should possess minimum 3 years' experience in the relevant field of marketing of AIR Conditioner. Proof must be attached.
- f) Bidder must produce non-Blacklisting Certificate of the firm on non-judicial stamp paper of Rs. 100/- duly attested by the Notary as per Annexure-I
- g) MSME Firms registered only in Haryana state are entitled/eligible for relaxation under this provision as per instructions of the appropriate Government/Authority.

#### 4. INSPECTION & DELIVERY PERIOD:-

- i. Inspection of the stores will be carried out by the supplier before dispatch. The final inspection of goods will be carried out at the consignee's site after receipt of the consignment. In case of defective supply due to latent manufacturing defects/transit damage, the same has to be removed and replaced at the supplier's cost. Payment against Bills/Invoice shall be released only after receipt of supplies and inspection and installation of AC by this office.
- ii. Supply of the material within 15 days from the next day of issuance of supply order to the Board's office. Goods to be supplied in stationery Store of Board at Bhiwani.

#### 5. Clarifications

i. BSEH shall endeavor to respond to the questions raised or clarifications sought by the Bidders.











However, BSEH reserves the right to not respond to any question or provide any clarification, in its sole discretion.

ii. BSEH may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Bidders. All clarifications and interpretations issued by BSEH shall be deemed to be part of the Tender Document.

#### **6.** Amendment of Tender Document


- i. At any time prior to the Bid Due Date, BSEH may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder, modify the Tender Document by the issuance of Addendum.
- ii. In order to afford the Bidders a reasonable time for taking an Addendum into account, or for any other reason, Board may, at its own discretion, extend the Bid Due Date.

#### 7. Terms & Conditions:-

- i. Secretary, BSEH reserves the right to reject the any bid/all bids at any time without assigning any reason
- ii. Response submitted by E-mail, Offline or any form other than mentioned above will not be acceptable and liable for rejection by BSEH.
- iii. It will be understood that the Bidders have quoted their rates after visiting of the site(s).
- iv. In case the successful bidder resiles from the offer within the validity of tender, the earnest money will be forfeited.
- v. Delivery and installation at the destination point should be completed within 15 days from the date of issue of purchase order failing which penalty will be imposed as per penalty clause. However, for any reason beyond the control of the bidder the extension of time may be granted upon application by the bidder in prescribed format. No claim for any compensation during the extended period shall be entertained and the Board decision in this regard shall be final.
- vi. Bidder should be authorized Retailor/Dealer of the company concern.
- vii. Dedicated /Toll Free Telephone No. for Service Support: Bidder toll free telephone no. for service support.
- viii. Installation and working demonstration of all the material supplied shall be the responsibility of the bidder.
- ix. The Secretary, Board of School Education Haryana, Bhiwani reserves the right to reject any bid which does not fulfill the conditions stipulated in the tender i.e., the bids not qualifying the specifications specified in the tender and other conditions stipulated in the tender will be rejected.
- x. Secretary, BSEH reserves the right to vary the quantity.
- xi. The Secretary, Board of School Education Haryana, Bhiwani reserves the right to reject any bid which does not fulfill the conditions stipulated in the tender i.e., the bids not qualifying the specifications specified in the tender and other conditions stipulated in the tender will be rejected.
- xii. If any such change causes an increase or decrease in the cost of or the time required for the Bidder's performance of any part of the work, whether changed or not changed by the order, an equitable adjustment shall be made in the value or time schedule, or both. Any claims by the Bidder for adjustment under this Clause must be asserted within thirty (30) days from date of the Bidder's receipt of BSEH's order for change.
- xiii. Secretary, BSEH may at any time, by a written order given to the Bidder, make changes to the Scope of the work.
- xiv. The Secretary, BSEH reserves the right to cancel the tender without assigning any reason thereof.
- xv. All Bidders/vendors must quote the price inclusive of all taxes, delivery, installation of the A.C. with stabilizer. No extra charges will be paid to the Bidder.
- xvi. The office will not provide any road permit to the successful bidder for the supply of the material at FOR destination.
- xvii. For any situation/reason beyond control of the bidder, the extension of time may be granted on an application/request of the bidder before completion of work. No claim for any









compensation during the extended period shall be entertained and the Board decision in this regard shall be final.

#### 8. PERFORMANCE SECURITY and EMD: -

- i. After receiving notification of award, firm have to deposit an Agreement as per contract form on Non-Judicial Stamp Paper of Rs.100/- duly attested by Notary along with 10% Performance Security of the total value of the tender within seven (7) days through RTGS in favour of Secretary, Board of School Education Haryana, Bhiwani failing which a penalty of rupees 500/- per day will be imposed for five days. Thereafter EMD may be forfeited and firm may be blacklisted.
- ii. Performance Security and EMD of Successful bidder will be returned after successfully completion of work and after final payment of the Bill.
- iii. The EMD of unsuccessful Bidders will be returned through the online payment portal.
- 9. <u>Arbitration Clause: -</u> All disputes or differences arising between the parties out of or relating to meaning and operation of effect of the contract or breach thereof shall be settled by arbitration in accordance with the rules and regulation of arbitrator. The sole arbitrator shall be appointed on mutual concurrence of both parties. However, it is the discretion of the Chairman to accept or not decision of the Arbitrator. The courts at Bhiwani only will have the legal jurisdiction in case of any dispute.
- 10. <u>BLACKLISTING THE FIRM:</u> If a firm which is awarded the contract violates any of the term & condition, if a Bidder engages in a corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice and if the Bidder withdraws its Bid during the Bid Validity Period as specified in this tender document and as extended by mutual consent of the respective Bidder(s) and the Board; it shall be black listed & its EMD/Performance Security shall be forfeited.
- 11. <u>Warranty</u>: All the items should be covered under onsite comprehensive warranty as per company policy from the date of installation.
- 12. **Warranty Support**: The total system will be warranted against bad workmanship and manufacturing defects from the date of acceptance of the system whole or part. Service support for the entire warranty period will be on site and comprehensive (including spares and all other support) and free of cost for the entire warranty period. The warranty must include, if not mentioned herein otherwise, but not limited to the following onsite services:
  - i. Free-of-cost all services required during the entire warranty period that should result in complete restoration of the equipment to its fully functional status.
  - ii. Must provide for free—of-cost complete replacement of the concerned module of the equipment, for any fault, malfunctioning or defect found in the warranty period.
  - iii. Provide for free-of-cost replacement of defective components/parts of the equipment for the warranty period.
  - iv. Provide for services of repair & maintenance for the warranty period.
  - v. Provide for repetitive replacement of defective parts subject to reduction of the warranty period of the concerned new part/component to the extent of the warranty life consumed by the old replaced part, counted from the date of start of warranty period.

#### 13. Payments:

i. The 100% payment shall be made after successfully Supply, Installation, Testing of A.C. with stabilizer and satisfactory report.

## 14. PENALTY CLAUSE-

In case of late delivery:

If the items are not supplied within the stipulated time period, the penalty will be imposed as under:-

- i) For delay up to 05 days -2% penalty on the payable amount.
- ii) For delay up to 10 days -5% penalty on the payable amount.

In case of non-supply of Item by the firm/supplier after getting the supply order, EMD and/or Performance Security deposited by the firm will be forfeited and firm will be Blacklisted for a specific period.

# 15. Fraud and Corrupt Practices

- i. If a Bidder is found by the Board to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, or after the issue of the LOI, such Bidder shall not be eligible to participate in any tender or TENDER DOCUMENT issued by the Board during a period of 2 (two) years from the date such Bidder is found by the Board to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practices, as the case may be.
- ii. For any point which is not covered under the provisions of the tender, the Secretary of the Board shall be the supreme competent authority, whose orders in any of such issues at all stages shall be final for one and all as a matter in the interest of Board.




