ANNEXURE-II

TERMS AND CONDITIONS

1. The quotationer must possess a valid **Unified License (ISP), Category-C**, issued by the competent authority and must attach documentary proof.
2. The quotationer shall **not be the existing service provider of the primary internet connection** installed in this office. Participation of the current ISP is **strictly prohibited**, as this connection is required as an independent backup link.
3. The connection shall be provided on F.O.R. Destination basis and must include all installation, configuration and related charges upto main router.
4. The internet service must be of standard quality with clearly defined bandwidth, uptime, and SLA conditions mentioned in the quotation.
5. The quotationer shall ensure that the connection remains fully functional and capable of acting as a **backup link in case of failure of primary connection**.
6. All necessary equipment supplied shall be of good quality and maintained properly during the contract period.
7. The minimum period of installation from the date of placing the order should be specified and must not exceed **10 days**.
8. All quotations will be deemed valid for at least **30 days** from and excluding the date of opening.
9. The quotationer shall provide necessary technical support and maintenance services without additional cost.
10. In case of breakdown of internet services, a **penalty of ₹50/- (Rupees Fifty only) per hour** shall be imposed for downtime.
11. The service provider shall ensure prompt restoration of services. Delay shall attract penalties as applicable.
12. The service must be provided satisfactorily within the stipulated period, failing which the Secretary, Board of School Education Haryana, Bhiwani reserves the right to make alternate arrangements at your risk and cost.
13. Your quotation may be accepted in part or whole.
14. In case your rates are valid for a certain period, posting of acceptance on the last day will be acceptable to you.
15. In case of any Government regulation, payment shall be made as per applicable rules or quoted rates, whichever is lower.
16. In case of any dispute, the decision of the Secretary, Board of School Education Haryana, Bhiwani shall be final and binding.
17. The firm must provide reliable and continuous internet service, failing which it may be **debarred/blacklisted** as per decision of the competent authority.

18. All services shall be provided "inclusive basis" covering all charges required for proper functioning. (2)
