- 1. The bidders shall upload their technical offer containing documents, qualifying criteria, technical specification and all terms and conditions except the rates (price bid).
- 2. The bidder shall quote the rates in online price bid format.

IMPORTANT NOTES:—

- 1. The price of this tender document is Rs. 1000/- (Rupees One Thousand only) non-refundable, which is to be deposited online and proof of deposit slip should be uploaded with the tender document.

For the calendar year 2023 & 2024 the same work for Middle class Exam. may also be included if the exam. of Middle class will take place.**

1. Eligibility Criterion for the bidders:-

- ➤ The Firm should have turnover at least Rs. 50 Lakhs average for the last three years i.e. 2019-20, 2020-21 & 2021-22 and balance sheets must be attested by the Chartered Accountant.
- The Firm should possess GST Number, PAN, (Scan Copies Attach)
- If any of the vendor at any time is found or was declared 'black listed' by any of the government organization/institutions/university for any of the reasons or so, then the same vendor would also be treated as black listed from our organization and further tender would be treated terminated and complete EMD would be forfeited. An undertaking on affidavit of Rs.10/-(Rs. Ten only)mentioning that the firm has never been black listed, to be deposited.
- > Firm can undertake software solution related jobs.
- 2. The firm will provide service with quality up to satisfaction of concerned authority.
- 3. The firm will have to give presentation 'How the service will be provided and give details about hardware and software required for the same' along with BID.
- 4. Supply of final data in required format and supply all type of statistical reports etc. as desired by board.
- 5. The bidder will have to ensure 100% accuracy of the input and outputs.
- 6. The bidder should have 3 years experience of developing application software in open software technologies, hosting of online application.
- 7. The bidder must have independently handle one assignments of similar nature work in any board/university during the last three years. The bidder must enclose the satisfactory completion performance certificate for the works executed.
