- Reference is made to the Memo No. T&A/2022/3213 dated 28-01-2022 issued by State Council
  of Educational Research & Training (SCERT), Gurugram wherein Board of School Education
  Haryana (BSEH) has been authorised to conduct Class 8<sup>th</sup> & 5<sup>th</sup> examination (Copy enclosed).
- 2. For the session 2021-22 the Board (BSEH) shall be conducting examination for Class 8<sup>th</sup> only.
- 3. Please ensure to direct & follow up all the Government and Recognised Private Schools even to whom N.O.C. has been issued for affiliation to any other Board for Secondary and Senior Secondary Examination by the Education Department, Haryana to register themselves with the Board (BSEH) for enrolment of their students for Class 8<sup>th</sup> examination on the board's website i.e. www.bseh.org.in by 15<sup>th</sup> February 2022.
- 4. All students studying in the Government and Recognised Private Schools situated in Haryana need to pass Class 8<sup>th</sup> Annual examination conducted by Board of School Education Haryana (BSEH) for admission to Class 9<sup>th</sup>.
- 5. Since the Board (BSEH) shall be conducting Annual examination for class 8th, therefore there shall be no Annual examination at the school level.

Regarding re-introducing examination for evaluation of students of Classes 5th and 8th in all govt, and recognized private schools of the state.

In compliance of the communication received from the office of Director Elementary Education, Haryana, Panchkula vide Memo no. 1/2, 2019 RTE (1) dated 19.01.2022 (copy enclosed) and in order to implement the provisions of Section 16 of Right to Children to Free and Compulsory Education Act, 2009 (with amendments introduced time to time), SCERT Haryana (Gurugram) being the 'Academic Authority' has been assigned the task of introducing regular examinations for the evaluation of students studying in classes 5th & 8th of all Government and recognized private schools situated in the State at the end of each academic year.

As the Board of School Education, Haryana (BSEH) holds expertise in conducting various state-wide academic assessments (majorly of Board classes), Eligibility tests/entrance exams; therefore keeping in consideration the experience that BSEH holds, SCERT Haryana would like to entrust the task of conducting regular examination of the students of classes 5 & 8 (as mentioned above) to BSEH, Bhiwani with the following key-point:

- (i) The examination/evaluation would be done as per the curriculum based on NCERT/SCERT Books and shall be made in terms of the provisions attached with the Rule 21 (1) (cc) of the above Rules 2011; which is further authorized to issue certificate of completion of 5<sup>th</sup> and 8<sup>th</sup> Class, as the case may be, and in terms of Rule 22 (1) of the above Rules of 2011
- (ii) Also, it is to made clear that the aforesaid authorization has been given to the Board merely for the purpose of holding the regular examination of 5<sup>th</sup> and 8<sup>th</sup> Classes, as detailed above. And it would not amount to granting of affiliation to the Board for such examinations of such Government and private recognized schools which are situated within the State to whom NOC for affiliation to any other Board for Secondary and Senior Secondary Examination has been given by the Haryana Education Department subject to such conditions as specified under Rule 33 of the Haryana School Education Rules, 2003.
- (iii) And lastly, if a child fails in the regular examination, he/she shall be granted opportunity for re-examination within 2 months from date of clarification of results. And if he/she fails in the re-examination, he/she shall be held back in the said class.

Pursuant to this, necessary steps should be taken by the BSEH, Bhiwani in this regard at the earliest and the Council be kept informed accordingly.
