## SPECIAL EXAM. BRANCH- Conduct of Haryana Teacher Eligibility Test

01- Who is eligible for Haryana Teacher Eligibility Test ?

Ans. All individuals who possess educational qualification for recruitment as a teacher in a School, as laid down by Haryana Government, is eligible for this test. Teacher Eligibility Test is mandatory for recruitment as teacher in any school of State Govt./Local authority referred to in the service rules and also RTE Act 2009.

02- When will be Haryana Teacher Eligibility Test conducted ?

Ans. This Test is conducted at least once in a year. Dates of test will be notified in the Newspapers and also through website of the Board i.e. [www.hbse.nic.in](http://www.hbse.nic.in).

03- What are the minimum educational qualifications to be a teacher in Haryana ?

Ans. The educational qualifications for various categories of teachers are decided by the State Govt./NCTE. Therefore, any information relating to the educational qualification for a teacher should be obtained from the School Education Department, Haryana.

04- What shall be the contents and structures of the ensuing HTET ?

Ans. The contents and structure of the test is based on the guidelines of NCTE and decision of School Education Department, Haryana. Contents and structure will be uploaded on the website of the Board well before the examination.

05- What are the qualifying marks for Haryana Teacher Eligibility Test ?

Ans. The qualifying marks for this test are decided by the State Govt./NCTE. The qualifying criteria for Haryana Teacher Eligibility Test 2011 was 55% (aggregate) for Scheduled Caste category and 60% (aggregate) for all other categories.

06- How many attempts for appearing in Haryana Teacher Eligibility Test are admissible ?

Ans. As per guidelines/instructions of Haryana Govt. for HTET 2011 there is no restriction on number of attempts a person can take for appearing in this test.

07- For how long an HTET Certificate shall be valid ?

Ans. As per instructions/guidelines of Haryana Govt. for HTET 2011 this certificate will be valid for five years from the date of qualifying HTET.

08- Whether weight age shall be given to HTET score in the recruitment process ? And also can a STET/HTET qualified candidate appear again for improving his/her score ?

Ans. As per instructions/guidelines of Haryana Govt. for HTET 2011 weight age shall be given to the HTET in the recruitment process. An HTET/STET qualified candidate can appear again in HTET for improving his/her score.

SPECIAL EXAM. BRANCH- Conduct of Diploma in Education Exam.

01- Who is eligible for Diploma in Education ?

Ans. Admission criteria for Diploma in Education is laid down by Haryana Govt. Therefore, any information regarding admission for Diploma in Education may be sought from School Education Department Haryana and SCERT, Gurgaon.

02- What is the duration for qualifying the Diploma in Education ?

Ans. Diploma in Education course is extended over a minimum period of three years including internship. Teaching in each academic year is divided into two semesters. A pupil teacher becomes eligible for internship after qualifying the examination of all the four semesters of this course.

03- What is the schedule of semester examination?

Ans. Generally, semester examinations are conducted in the months of February & October every year.

04- When teaching of next semester starts ?

Ans. After completion of examination of each semester break period is permissible in the curriculum/instructions. The teaching of next semester starts after termination of semester break period. Every pupil teacher who becomes eligible for higher semester is required to attend classes to complete the course of next semester.

05- What should I do in case I have not completed the prescribed course of any semester and declared ineligible for appearing in the examination owing to shortage of attendances?

Ans. Such pupil teacher will have to take readmission in the same College/Institution in the same semester and they will be allowed to appear in the examination of that semester only after completing the course/attaining the required minimum attendance and fulfillment of other eligibility requirements. Such pupil teacher will not be allowed to attend classes of higher semester

06- What should a pupil teacher should do in case of discontinuation of studies due to unavoidable circumstances?

Ans. Such pupil teachers shall have to take admission within a year from the discontinuation of studies in the same College/Institution to continue his/her study of remaining duration of the course.

07- What should a pupil teacher do in case of disqualification for a specified period?

Ans. Such pupil teachers will not have to seek re-admission for the course which he/she had completed and fulfilled all eligibility conditions. He/she will be termed/considered as Ex-Pupil teacher and shall be eligible for the examination of that semester after expiry of disqualification period, if other wise eligible. Other eligible conditions have been specified in examination regulations.

08- Whether a female candidate selected for the D.Ed. course can be deprived of admission to D.Ed. course due to pregnancy or such similar circumstances?

Ans. No, such candidates shall be allowed provisional admission subject to completion of all formalities and such provisional admission shall be regularized on submission of medical certificate from appropriate Medical Officer and she will be allowed to appear in examination subject to fulfillment of prescribed attendances, etc.

09- Whether a pupil teacher who does not qualify in External Practical Examination shall have to appear in the ensuing examination both for External Theory and External Practical Examination of that course?

Ans. No, such pupil teachers shall have to appear in the External Practical Examination only in the ensuing examination.

10- Who is competent to condone the shortage in attendance?

Ans. The Head of College/Institution, for the reasons to be recorded in writing, may condone up to 10% of short attendance. The Secretary of the Board can condone further shortage of attendance to the extent of 15% on the recommendation of the Head of the Institution subject to the conditions defined in the examination regulations.

11- How to know about D.Ed. examination regulations/scheme of examination etc?
