Annexure-II

**General Terms and Conditions**

1. The entire work is time bound nature and the firm/company will have to execute the work as per schedule by the BSEH.
2. Payment norms of the BSEH shall be followed. Request for advance payment shall not be entertained in any case. Payment shall be released after satisfactory completion of the work duly certified by the competent authority. If the work is found un-satisfactory then the Chairman/Secretary, BSEH will have the right to impose any penalty as he deems fit.
3. Rates quoted must be inclusive of all applicable taxes and other charges.
4. The BSEH reserves the right to reject any bid without assigning any reason and failure of the Board to select the Quotationer/Firm shall not result in any claim whatsoever against the Board.
5. The Quotationer neither have been Debarred/blacklisted by any Central/State Govt. Department/University/Education Institutions/Organization nor have any litigation enquiry pending with any of these Department or court of Law with regards to the works executed by it.
6. In case of any dispute the decision of the Chairman/Secretary, Board of School Education Haryana, Bhiwani shall be final and binding on you.
7. If the work done by the Firm is satisfactory then the work period can be extended as long as needed.
8. Resolution of disputes:-
  - i) The Board and the Supplier/Service Provider firm shall make every effort to resolve any disagreement or dispute arising between them amicably by direct informal negotiation, under or in connection with the contract.
  - ii) If, after such informal negotiation, the Board and the supplier/Service provider firm are unable to resolve amicably a contract dispute, either party may require that the dispute be referred for resolution to the formal mechanism specified as follows:-

“Any dispute or difference arising out of or connected with the contract, will mandatorily referred to the sole arbitrator appointed by the Chairman, BSEH and its decision will be final and binding on both the parties”.
  - iii) The venue of arbitration shall be within the discretion of the arbitrator to be appointed by the chairman.
  - iv) Only after the decision of arbitration, either party can approach the court of law for this purpose the legal jurisdiction will be Bhiwani (Haryana) only.
