TERMS AND CONDITIONS

1. The contract will be awarded initially for a period of one year.
2. The Contract may be renewed on year-to-year basis for a maximum period of next two years, subject to providing satisfactory services as per terms and conditions of contract.
3. The Annual Maintenance Agreement (AMC) will be inclusive of services of all 08 water purifier after every three months and all spares and consumables except Housing, UV Barrel and candle stand.
4. In case of any defect/fault in any water purifier, the firm will have to undertake the job immediately on receipt of the complaint and ensure the water purifier is brought to working condition within 02 working days. If the services are not provide within the stipulated time, the contractor shall be liable for payment of penalty of Rs. 200/- per day per water cooler. BSEH will have the option for taking services from other agencies and recover the cost from the firm to whom AMC is given.
5. In case, no action is taken on complaints related to AMC within 03 days, the contract of the firm can be cancelled without assigning any reason.
6. The Firm should not be debarred/blacklisted by the department of industries & commerce or any other government department/agency of the state.
7. In case of any dispute the decision of the **Secretary, Board of School Education |Haryana, Bhiwani** shall be final and binding on you.
8. The contract can be cancelled at any stage without assigning any reason, if the services are not found satisfactory.
9. Incomplete Quotation in any aspect, is liable to be rejected without giving any notice.
