- I. The installation of Live CCTV should be made at least one day in advance from the scheduled date of examination and or in such a way that the CCTV are required to be functional for one hour before the scheduled time of commencement of the examination and ¹/₂ hour after the completion of the examination.
- II. To organize and provide required manpower to install the CCTV devices at the Centers.
- III. To provide uninterrupted service of Live CCTV with software to view in a single click in Board's Control Room.
- IV. During the period of examination, Live CCTV facility shall not be interrupted due to any technical fault, etc., and the Agency shall take due care of functioning of Live CCTV with adequate backup of Live CCTV during the conduct of written examination and as per the time period mentioned in the Work Order of respective assignments.
- V. Power backup and other arrangements on every center would be done by the bidder.
- VI. The hardware required for the job shall be procured and maintained by the service provider and Training/sensitization of staff deployed at the examination centre's shall be impacted by the service provider.
- VII. Setup Dash board/video wall for showing complete details like working cameras, non working and filters (District, Centre Code, Room No., Camera No. with real time display) for Images in control room Bhiwani.
- VIII. Internet, Power backup and other arrangements on every center would be in the scope of bidder.
- IX. Bidder will give live demo one day before the exam.

The above scope of work also includes the following in addition to above:

- The bidder will have to ensure that the CCTV Wired Cameras work properly, during the entire duration of the examination in the Centre's or as ordered.
- The bidder will have to install minimum 2 megapixel CCTV camera in the Centre.
- One LED Screen should be provided in every centre incharge room.
- 44 LED (43 inch.) per district 02 LED with sufficient men power at main control room, Bhiwani. No extra payment will be made for this.

2. The Bidder should satisfy the following criteria:

- (i) Whether the Firm or organization, is a partnership or proprietorship or Limited Company, it must be clearly mentioned in the tender. 3. Documents:

- i) Documentary evidence in support duly certified by Authorized Signatory. The required completion certificate of above mentioned eligibility criteria must be enclosed.
- ii) Copy of registered partnership deed in case the firm is in partnership/ Copy of shop Establishment certificate in case of Proprietorship and Memorandum of articles in case the firm is Private Limited / Public Limited Company along with copy of registration.
- iii) The bidder has to undertake that the firm/individual State has not been blacklist from participation in tender anywhere in Central/state govt. Depts. /Central Govt. PSUs /Consumer Society approved by Central Govt.

TERMS AND CONDITIONS

- 1. The technical bid shall contain the specified documents or as claimed by the bidder fulfilling the eligibility and should be signed by the bidders failing which the bid will be summarily rejected.
- 2. The rates quoted should be exclusive of all taxes.
- 3. The examination centers are all over Haryana. The Board may add/remove city of examination which will be informed to bidder well in time.
- 4. The Board reserves the right to restrict and deny the entry to any staff member of the bidder, if so deemed appropriate by it, in examination centre.
- 5. The bidder will ensure that the staff engaged are disciplined and maintain full decorum of the office.
- 6. The successful bidder shall make arrangement for check-up of the CCTV at his own cost and shall keep all the machines in perfect working condition at all time, so as to ensure smooth running of work. In case of failure of any of the CCTV, the bidder shall have to make alternative arrangement immediately so that the work does not suffer.
- 7. The CCTV surveillance should have Power backup for continuous working.
- 8. Continuance of the contract and payment of the work done shall be subject to satisfactory performance and fulfilling of all the terms and conditions of the contract duly certified by concerned officer/ in-charge. The contract may be cancelled at any time without assigning any reason for the same. The decision of the Chairman, BSEH in this regard shall be final and binding.
- 9. Where a single examination centre is established in a building, Total 16 cameras (two cameras at main gate, 13 cameras (one in each room) & 01 camera in the control room of Centre Supdt.) have to be installed along with an LED of 21" inch display with DVR system for online Display.
- 10. Where two exam centres or more have established in a single building & the entrance is common only two cameras of entrance/main gate of the building will be counted for all examination centres. Control Rooms of each examination centre shall have to be established separately.
- 11. If the number of examinees in any of the exam centre increases or Decreases, then number of cameras will have to be installed according to number of examinees & the payment will be released as per number of cameras.
- 12. Time is the essence of the contract and the bidder shall adhere to the time schedule as prescribed by the BSEH for execution of the work.
- 13. If it is found at any time that the CCTV is not functioning in accordance with the agreed terms and conditions, the BSEH shall be entitled to withhold all payment of the bidder and forfeit the performance security.
- 14. The bidder will ensure that the space provided to it by the BSEH is not misused in any manner.
- 15. An appropriate agreement will be executed by the successful bidder with the Board, on the agreed terms and conditions.

- 16. The Board, in its discretion, reserves the right to reject or accept any bid without assigning any reason thereof.
- 17. If work gets stopped due to fault of the bidder, then penalty shall be levied for such stoppage at such rate as given in penalty clause.
- 18. The service provider is advised to visit all the Centers well in advance of the examination date to get acquainted with the available facilities at the center.
- 19. The Bidder's turnover in last three financial years shall be on an average two Crores (Supported by Financial statements, Balance Sheet duly certified by the Chartered Accountant) (total six crores turn over in last three years i.e. 2019-20, 2020-21 and 2021-22). The bids with annual turnover less than prescribed limit will not be considered for evaluation process and would be rejected without assigning any reason.
- 20. Wired Camera's be installed as Jammer Services will be in center.
- 21. Software must display the images at once with filters district/centre/room no. wise.
- 22. Performance Security needs to be submitted by successful bidder before signing of agreement between Board and successful bidder.
- 23. The Bidder will have to provide internet connectivity and uplinked facility without interruption for live viewing of conduct of examination centre. Bidder to ensure at least 85% Live Camera feed is available at control room, Bhiwani at all time during the entire duration of examination.
- 24. If the examination is postponed for any reason, then in such situation if the information is given within 48 hours from the beginning of the examination then 20% amount will be paid. If notice is given before 48 hours no payment will be made.
- 25. The Live CCTV camera's satisfaction work will be 85% compulsory.
- 26.The remaining 15% payment of the offline examination centers will be done according to offline rates, but it is necessary to submit data of offline examination centers.
- 27. If there will be penalty/deductions are 30% or more out of total amount then successful/satisfactory work certificate will not be issued.
- 28. The Bidder is required to submit complete recording level wise/district wise of the entire examination in hard disk within 20 days of successful completion of the examination.
- 29. Data backup with real time and date of centre's showing will be given on hard disk with software to see at once the video.
- 30. Bidders have to provide online status of working cameras, non-working cameras on the exam day live screen.
- 31. Due to examination being very important, keeping in mind the quality of the firm in order to maintain its eligibility, sanctity and confidentiality, work can be allotted to any firm by the board authority.

- 2 If any camera full recording not found in data supplied to Board, deduction will be as under-01 minute to 45 minutes- Rs. 125 only.
 - 01 minute to 90 minutes- Rs. 250 only.

Above 90 minutes- Rs. 500 & original payment per camera quoted by the vender will not be given.

- 3. If agreement and performance security is not deposited by successful bidder in the scheduled time then penalty of @ Rs. 1000/- per day will be imposed.
- 4. If a dispute arises out of or in connection with this contract, decision of the Board Chairman shall be final and binding. All disputes in this connection will settled in jurisdiction of Bhiwani Court exclusively.
