As you are aware the Government of India in 2019 launched a national program, the Jal Jeevan Mission. The mission aims at providing tap water supply to every rural household in the country by 2024. The campaign also aims at providing piped water supply for drinking, toilet use and hand washing facilities in schools. It also calls for rainwater harvesting in school premises. With increased recurrence of water shortage across the county the significance of the mission has increased manifold.

- 2. Availability of running tap water facilities in all schools is a necessary pre-requisite for ensuring sanitation and hygiene and for ensuring the health and well-being of our children. Therefore, the inclusion of such facilities as a parameter for affiliation of Government, Government aided and Private schools should be considered. Additionally, conservation of water through efforts like Rain Water harvesting may also form an integral part of the parameters for affiliation of all schools to scale and increase the efforts towards water conservation.
- 3. It is therefore requested/ advised that the availability of Rain Water Harvesting facilities and availability of clean drinking water facilities through tap connection and availability of running tap water in toilets may be taken into consideration as a parameters for affiliation of schools.

The State Board Authorities may be requested to include these conditions for granting affiliation to schools.
