### Notification-2

In exercise of the powers conferred upon by sub clause (3) of 12, Act-11 of 1969 of the Board of School Education, Haryana, The Chairman has made the following approval of new policy amending the notification issued earlier on 02.07.2021 with respect to Senior Secondary Examination March/April result.

**New Policy regarding the declaration of Result of Senior Secondary Examination Haryana Open School March/April-2021.**

### Background:

Due to Covid-19 epidemic the Board had to postpone the Senior Secondary March/April 2021 examinations to be conducted under the open School System as per the directions issued by the Director of Secondary Education Haryana, Panchkula vide Memo. No. 10/4-2020 ACD (15) dated 15.04.2021, Point No.-02.

1. On the basis of aforementioned Memo, the Board of School Education Haryana prepared a policy according to the directions of the Hon'ble Supreme Court & Govt. of India to declare result of Secondary & Senior Secondary Examinees (Regular school Examinees) for which a notification No: 567/शैक्षिक/ए-2 दिनांक 02.07.2021 was issued by the Board of School Education Haryana in which the policy was made public.
2. In the previous notification (Page No. 6, Point No. V) it was decided that if any examinee remains absent in any one subject/subjects in the Secondary/Senior Secondary Practical examination or marks of Internal Assessment have not been received by the board in such a case minimum 33% passing marks will be awarded in that subject and if marks have not been awarded in all practical subjects/internal assessment in such cases the examinees will be marked as absent. Those examinees who have been awarded 6 or less than 6 marks in the Internal Assessment by the concerned school will be considered to have been awarded minimum 33% passing marks in that subject/subjects.

3. The result of Secondary and Senior Secondary of Haryana Open School as per Notification (Page 07, Point No. XI) is as follows:-
  - Secondary Class students of open school under fresh category appearing in all subjects shall be awarded minimum 33% passing marks & their result shall be declared.
  - Senior Secondary Class examinees under Haryana Open School shall be awarded marks bases on their score in Secondary examination.
4. To prepare the result of Sr. Sec. Exam under Haryana Open School a high level meeting of board officials was arranged in which a detailed discussion was done on the issue that similar to the result of Secondary regular Candidates, if any examinee is absent in any one or more subject/subjects in practical examinations or the school has not sent internal assessment marks, in that condition minimum 33% marks will be considered in that subject/subjects and those examinees who have been awarded 6 or less than 6 marks in that condition minimum 33% marks will be considered in that subject/subjects; the same provision will be appropriate in Sr. Sec. Exam of the Haryana Open School because there is no record of the examinees of open school regarding written/practical/INA of any of the subject. In such a situation when there is no record of any subject (regarding Sr. Sec. Exam) considering only secondary Examination as the base and deciding the marks of Sr. Sec. needs to be consider under a uniformity approach.
5. Other than this, while preparing the result of the regular students/examinees, 30% of the marks of 10<sup>th</sup> class, 10% of the result of 11<sup>th</sup> class of the examinees and 60% weightage to the INA marks of 12<sup>th</sup> class has been given. This way, to prepare the final result of Sr. Sec. regular examinees weightage (30%, 10%, 60%) has been given to all the three classes 10<sup>th</sup>, 11<sup>th</sup>, 12<sup>th</sup> respectively. It was not considered to prepare the result of Haryana Open School on the basis of same policy because of non-availability of evaluation record of 11<sup>th</sup> & 12<sup>th</sup> classes.
6. According to the notification (Page No.- 9, Point No.-XV) provision, the Chairman of the Board has been authorized to solve any type of issues related to the result; in lieu of the same power the Chairman passed the order to prepare the result by making certain amendments in the notification



policy. Hence the result of Open School Senior Secondary examination may be declared with minimum 33% passing marks.

7. The amendments/changes in the policy done by the Chairman B.S.E.H. will be discussed in the Committee for Academic matters next time for information.
8. As per the description given in this notification, the result of Senior Secondary Examination Haryana Open School Annual Examination 2021, will be declared on the basis of minimum 33% passing marks.
9. If any of the candidate is not satisfied with his/her result, he/she can appear in forthcoming examination to be held in the month of August/September.
