Eligibility Conditions

1. Minimum experience of three years with proven track record of online website/application hosting of Govt. /Education Board/Institute/University.
2. The job will have to be completed within a maximum period of one month. However, in view of exceptional circumstances considered as beyond the control of IT Agency, the Chairman of the Board may grant extension of time period to the maximum of fifteen days.
3. Only such IT companies will be considered for the allotment of work which are having adequate infrastructure, experienced and qualified manpower, and development of software and experience of processing in the relevant field with proven track record, the Chairman or his authorized nominee shall have the right to inspect premises of the firm before allotment of work.
4. The Chairman of the Board shall have the authority to allot the work in the manner he deems fit.
5. The Bidder will be required to submit Performance Security of Rs. 10,000/- in shape of bank draft/RTGS after allocation of work within 5 working days.
6. It shall be the responsibility of the firm to keep the contents/information of the website strictly confidential. Failure to comply with this condition shall make the party liable to legal action and other damages as may be fixed by the Secretary/Administrative Head of the Organization.
7. If a quotationer refuses to execute the allotted work or delays the work unnecessarily, Performance Security will be forfeited and the firm may be blacklisted for a specific period. The decision of the Chairman of the Board in such cases will be final and binding on the quotationer.
8. The payments will be made on the basis of one time Software Cost. Payment shall be made on submission of bill after satisfactory completion of work in all respects.
9. In the case of any dispute of any other point not covered under the above terms & conditions, the case will be referred for arbitration to the Sole Arbitrator i.e. Chairman of the Board whose decision shall be final and binding on both the parties.

1. Scope of Work :-

- Creation of a dynamic website with international standards – bilingual (Hindi and English)
- Compliance for GIGW (Govt. of India Guidelines for Website) and other Government guidelines; the vendor has to complete the formalities for compliance of Government guidelines, security audit through Government technical auditor etc. where BSEH staff would facilitate for the same.
- The vendor will be provided all services in new website which is already running on old website(bseh.org.in)
- In new website vendor will add following application/features in website :-
 - Vendor will develop a robust platform separately to display result of all classes. BSEH displayed result approximately 15 Lakh students every year. So, this part of website is more important and very sensitive. During the result displaying approximately 2 million students can come to see at once. The common data structure for all classes will be made available to firm. Admin of website will upload and update all result on website. If any changes is required in this part vendor will change required changes on priority.

 - Informative and content rich for stakeholders
 - Easy user interface

- Maintenance of website (for one year) : The vendor has to deploy sufficient technical, graphics, language experts to maintain and update the website.
