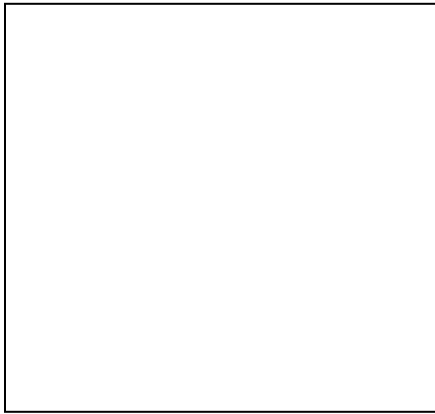

In case of Military personnel the applicant can get it attested by the commanding officer of his unit.  
Attestation of the following persons only will be accepted:

- [1] Gazetted Officer [2] First Class Magistrate [3] Headmaster/Headmistress/Principal of a recognised High/Senior Secondary School or of an affiliated college [4] An Officer of the Board not below the rank of Assistant Secretary.  
A person applying for change of his/her name in the Board shall submit his/her application.
- [a] In the case of regular student, through the Principal/Headmaster/Headmistress of the College/School last attended by him/her.
- [b] In the case of private candidate, through a Gazetted Officer or the Headmaster or the Principal of a recognised High/Senior Secondary School or an Officer of the Board not below the rank of an Assistant Secretary, or [in the case of a Government employee] through the Head of the Department in which he/she is employed.

**Accompanied by:**

- i) A fee of Rs. 300/- per correction, Rs. 500/- per certificate and maximum fee for correction Rs. 1100/- .
- ii) An affidavit relating to his present and proposed names duly sworn in the presence of a Magistrate by his/her parents or guardian in case he/she is a minor or by himself/herself in case he/she is major, and
- [I] A cutting from a daily newspaper in which the proposed change of name has been advertised.
- [II] Change in surname is not permissible unless there is any link between the proposed and the one already shown against his/her name. This rule does not apply to women candidates who change their names due to marriage.
- [III] Women candidates change in whose name has been made due to marriage, have only to submit an affidavit duly attested by a magistrate to this effect. Advertisement in a newspaper is not necessary.
- [IV] Duplicate certificate with changed name can be issued on payment of the prescribed fees and on return of the original certificate. This fee will be in addition to the paid for change in name.
